on the 21st of January 1919 and my Granduncle
Tom McGuire placed the Sovereign Seal
of Dáil Éireann in the Mansion House
Dublin for the First Dáil Éireann on
behalf of the Irish Republican Brotherhood,
and the Sovereign Seals of Dáil Éireann.

old Irish Harp. The Brian ~~Bobu~~ Harp and
the sequence of events. The Fenian Brotherhood
standard (The Sovereign Seal on a Green
background with a gold Braid). The Green
and Gold. The Irish Republican Brotherhood
standard (The Sovereign Seal on St. Patrick's
Blue background with a Gold Braid).
and after the 21st of January 1919. The Irish
Republican standard (The Sovereign
Seal of Dáil Éireann on St. Patrick's
Blue background with the Four Province
Emblem of Ireland and a thirty two gold
braiding edge.

The Harp is the reverse side
of the Sovereign Seal of Dáil Éireann
used by Guinness as their Trade Mark.
The Sovereign Seal of Dáil Éireann
is on our coins and used to be on our
Bank notes and the Sovereign Seal of
Dáil Éireann is on our Passports.
We enter a Foreign Country as Sovereign
Citizens

The G.A.A. is entitled to have

the Sovereign Seal of Dáil Éireann on their Emblem. Sam McGuire, who was secretary of the Irish Republican Brotherhood, was also Tom McGuire's secretary in Vaughans Hotel, and Liam McGarthy took over in London for Sam McGuire when he was in Vaughans Hotel. Tom McGuire's Mother was a McColl.

The legitimacy of the Irish Courts comes from the Implementing of the 1916 Proclamation, The Sovereignty and the establishing of the Dáil Éireann Courts on the 21st of January 1919. and Vested in Vaughans Hotel, by my granduncle Tom McGuire on behalf of the Irish Republican Brotherhood.

The Sovereign Seal of Dáil Éireann is over the Irish Courts

The Judiciary is independent of the Government

The Government has to be elected by the Sovereign Irish People and are subject and accountable to the Sovereign Irish People and are the elected Sovereign Seal holders of Dáil Éireann

The Judiciary (The Judges), are the ("Appointed"), Sovereign Seal holders of

Dáil Éireann.

One of the duties of the President is to hand over the Sovereign Seal of Dáil Éireann to the elected Sovereign Seal holders, (The Cabinet), and the appointed Sovereign Seal holders of Dáil Éireann (The Judges). On behalf of the Sovereign Irish People and to remove them from the Sovereign Seal holder who corrupt Dáil Éireann.

If Óglaigh Na hÉireann is an illegal organisation. Then you must arrest the President Mrs. Mayhew who is commander-in-chief of Óglaigh Na hÉireann, The Ceann Comharaí Mr. Thomas Paterson T.D. I am the present Sovereign Seal holder of Dáil Éireann and it took over seven hundred years and my families fortune to get the Sovereignty and Sovereign Seal back in the War of Independence. That is what the Irish Volunteers, Irish Citizen's Army, the I.R.A and Óglaigh Na hÉireann gave their lives for in the War of Independence "Sovereignty" and defending the sovereignty of Dáil Éireann and the sovereignty of the Thirty two Counties (32).

The Crown of England does not have sovereignty in Ireland, North or South, and has no right to have the Sovereign Seal of Dáil Éireann on its Coat-of-Arms. That is what has caused all the Conflict between Ireland and England.

The Crown of England has no right to have Crown Forces (Army) in Northern Ireland. It was giving the Crown of England jurisdiction (Police Force) and the Oath of Allegiance that caused the Civil War in Ireland
