I must Protest  
and complain to the removal of the Sovereign  
Seal of Dáil Éireann from our legal  
Tender. (Bank Notes). by the Central Bank  
of Ireland and the Department of Finance  
It is Treason.

The Central Bank of Ireland  
and the Department of Finance has no  
right to interfere with the Sovereign  
Seal of Dáil Éireann or trespass  
into the sovereignty of Dáil Éireann.

The Sovereign Seals of  
Dáil Éireann are still the Property of the

The Sovereignty comes from  
the 1916 Proclamation and was implemented  
by my granduncle Tom Mc Guire on the  
21<sup>st</sup> of January 1919 in "Vaughans Hotel" 29 Park  
Square Dublin and the Sovereignty was  
vested on the same day the 21<sup>st</sup> of January 1919.

and my granduncle placed the Sovereign  
deal of Dáil Eireann in the Mansion  
House Dublin - for the first Dáil Eireann  
on behalf of the Irish Republican Brotherhood  
Tom Mc Guire coordinated the establishment  
of Dáil Eireann on the 21<sup>st</sup> of January 1919.  
and the "War of Independence" on the  
21<sup>st</sup> of January 1919. and declared from  
"Vaughans Hotel". The first shots were fired  
were the first shots and all on behalf  
of the Irish Republican Brotherhood!  
who still hold the Sovereignty of Dáil  
Eireann and the Sovereignty of the Thirty-two  
(32) Counties

I am the Heir to "Vaughans  
Hotel" and the Present Sovereign deal  
holder of Dáil Eireann and Claims  
the Assets of the Central Bank of Ireland  
on behalf of the Irish Republican  
Brotherhood. My family the Mc Guire's  
have held the Sovereign deal of Dáil  
Eireann from 21-1-1919 - 21-1-2001. 82  
years on behalf of the Irish Republican  
Brotherhood

The sovereign seals of Dáil Éireann are based on the design of the old Irish Harp. The Brian Boru Harp and the sequence of events. The Fenian Brotherhood standard. The sovereign seal on a green background with a gold Buid, The Green and Gold. The Irish Republican Brotherhood standard.

The Sovereign Seal on St Patrick's Blue background with a Gold Braid and after the 21<sup>st</sup> of January 1919.

The Irish Republican Standard  
The Sovereign Seal of Dail Eireann on St Patrick's Blue background with the Four Province Emblem of Ireland and a Thirty two Gold Braiding Edge

The Harp is the Reverse side of the Sovereign Seal of Dail Eireann used by Guinness as their Trade Mark. The Sovereign Seal of Dail Eireann is on our coins and Bank notes and the Sovereign Seal of Dail Eireann is on our Passports. We enter a Foreign Country as Sovereign Citizens

The G.A.A. is entitled to have the Sovereign Seal of Dail Eireann on their Emblem. Tom McGuire, who was secretary of the Irish Republican Brotherhood was also Tom McGuire's secretary in "Voughans Hotel" and Liam McCarthy took over in London for Tom McGuire when he was in Voughans Hotel. Tom McGuire's

mother was a <sup>v</sup> Mc Carthy
