Dear Taoiseach,

It is Mandatory for the government to be properly constituted. Neither of the houses of the Dáil Éireann is properly constituted today, nor have they been since 1922.

The Protocol that my family put in place on the 21-1-1919 in the Mansion House, Dublin, on behalf of the Irish Republican Brotherhood and Óglaigh Na hÉireann, for the first Sovereign Republic of Éire. The Trinity. The Sovereign Seal A.D. 1919. 12 strings. The Tri-colour on the Óglaigh Pole and The Harp 12 strings B.C. It is Mandatory for The Sovereign Seal A.D. 2010. 12 strings and The Tri-colour to be in Dáil Éireann to day 2010. and elevated over the seat of the Ceann Comhairle. The Harp B.C. (our National emblem) must be elevated above the seat of the Cathaoirleach. The Harp with 12 strings, is the reverse side of The Sovereign Seal of Dáil Éireann.

My Mandate that I hold to claim The Sovereignty over all the Territory, Rivers and Lakes, seas, Fishing, Fishing Rights, Mineral Rights, Licenses and all the assets of the state and turn The Sovereign Seal of Dáil Éireann, (12 strings) A.D. comes from the 32 County

election of 1918 from "Vaughans Hotel" G.H.Q.  
Dublin and on The 21-<sup>st</sup> - 1919.

The Irish Republican Brotherhood established and own, The Sovereign Republic of Éire, Dáil Éireann and The Dáil Éireann Courts (4 Courts) on the 21-<sup>st</sup>-1919. at 12 Noon in the Cabinet Room in the Mansion House Dublin, and the 32 County election of 1918, from G.H.Q.
