Dear Judge Hogan,

my complaint
to President Michael D. Higgins and an
Taoiseach, regarding President Michael D.
Higgins inaugural Speech at Dublin
Castle on the 11-11-2011. (enclosed). When
he said."That next year Bunreacht No
h Éireann is 75 years old and a
constitutional convention is planned
by Government." (Provisional Government).

My complaint has been ignored
by President Michael D. Higgins and
an Taoiseach.

Bunreacht No h Éireann is
93 years old and is the property of The
Irish Republican Brotherhood and was
written between 1917 and 1919 in G.H.Q.
"Vaughan's Hotel" 29 Parnell Square and
Gumby Row Dublin and paid for by
My Family on behalf of The Irish Republican
Brotherhood, for the First Sovereign
Republic of Éire, Dáil Éireann, The
Dáil Courts (4 Courts). The Sovereign
Citizens and The President of The Irish
Republican Brotherhood, who is
Head of State, (The Sovereign Republic of Éire)

and is The President, that is Referred to in Bunreacht Na hÉireann (article 12). and holds The 32 County Mandate as defined in The 1916 Proclamation. The Foundation document of this State. The Sovereign Republic of Éire. (Article 5). "Ireland is a Sovereign, Independent Democratic State." "Sovereign and Indepeasible".

You are the authority on Bunreacht Na hÉireann and I am appealing to you to put the record straight.

The State (article 4)

The name of The State is Éire.
when and where was The State Founded ?
when and where was Bunreacht Na hÉireann written ?
when and where was the 1916 Proclamation and Bunreacht Na hÉireann Ratified ?

Bunreacht Na hÉireann was written by The Irish Republican Brotherhood exactly and verbatim as defined in The 1916 Proclamation and both documents were Ratified on the 21-1-1919 at 12 Noon in the Cabinet Room in The Mansion House Dublin in The First Dáil Éireann (Private session). and derive their legitimacy from the 1918. 32 County election from G.H.Q. "Vaughan's Hotel" and The First Dáil Éireann

Dáil Éireann sat later on the same day the 21st, - 1919, in The Round Room in The Mansion House at 3 for 3.30 and conducted the Business of The State.

The Sovereign Republic of Éire.

The name of The State is Éire. (article 4) and was paid for by The McGuire family.

Bunreacht Ná hÉireann can only be changed by a 32 County Vote of the Sovereign Citizens.

The changes that were imposed on Bunreacht Ná hÉireann in 1922 by King George V of England in the Constitution Room in the Shelbourne Hotel Dublin and the changes that were made by Mr De Valera in 1937, are not legal, Valid or Bona Fide for that Reason.

It is mandatory that the forthcoming Referendum on the 31-5-2012 on the changing of Bunreacht Ná hÉireann on the E.U. Fiscal Treaty is a 32 County Referendum.

Dáil Éireann has never Ratified the E.C. accession Treaty. The E.C. accession Treaty or any other E.U. Treaty or the Good Friday/Belfast agreement, nor caused Dáil Éireann Ratify any agreement since Dáil Éireann has not sat since 1922, when it was made an illegal assembly by King George V. We have only a Provisional

Government since ¹⁹²² and they do not have that Right.

The State, the Sovereign Republic of Eire will only Recognize a 32 County Vote to the changes Bunreacht No h Eireann.

President Michael D. Higgins has said that Bunreacht No h Eireann is 75 years old in 2012.

What Bunreacht No h Eireann/Constitution are the 4 Courts using? If any Article 5 "Ireland is a Sovereign, Independent Democratic State"

Where are the 4 Courts getting their Sovereignty from?


