IRISH REPUBLICAN BROTHERHOOD

Dear Mr Justice Clarke,

The Irish Republican Brotherhood (IRB) note that you are retiring as chief justice at the Four Courts Dublin in October 2021.

The IRB who founded and funded the state, The Sovereign Republic of éire in the 1918 32 county all Ireland Democratic Election called by Britain on 14th of December 1918 and on the 28 of December 1918 (IRB Sinn Féin) won 73 seats. The unionist party won 25 seats - The nationalist Party won 6 seats, The independent party won 1 seat out of a total of 105 seats, The Irish Fenian Republican Brotherhood (IRB) still hold that mandate today and was ratified on the 21st-1-1919 at the Mansion House Dublin and GHQ Vaughan Hotel Dublin by the Sovereign Dáil éireann Government of the Sovereign Republic of éire all 32 counties, land, territory and Seas.

The Irish Republican Brotherhood (IRB) would like to know what oath of allegiance if any are you taking to uphold the law at the Four Courts, and to the state the Sovereign Republic of éire?

All the sovereign elected politicians (Teachta Dála) and judiciary and civil servant had to take an oath of allegiance to the state the Sovereign Republic of éire, the Sovereign Dáil éireann government, all 32 counties, the Sovereign Dáil éireann courts (4 courts) and be accountable to the Sovereign people - citizen on the 21-1-1919 in the Mansion House Dublin our independence day. Do you still take the same oath?

The contempt that you have for me as the anointed Sovereign President of the Sovereign Republic of éire, all 32 counties, land, territories and seas is unjust (from our border with Britain down the Irish Sea to our border in the Atlantic Ocean with the USA and Canada). The contempt of the judiciary and the free state Provisional Government for the IRB is unjust and fraud.

My high court case at my farm 'Oorid recess PO Connemara, County Galway' is a fraud. The high court claimed that it did not have jurisdiction to hear my case number 2002/6783 P. and breached my constitutional right to farm and forest my land, cut turf, keep livestock and bloodstock on my land and earn my livelihood and get EU grants and payment. All my land was designated A.S.I. NHA. SAC by the Free State Provisional Government without any consultation with me. The Supreme Court ruled that the farmers' right to farm were breached (enclosed Blayney Judgement). My constitutional right to farm was breached. All my land is still de-stocked today.

The two five string harps that are over the Four Courts are not properly aligned. They were on the Ark of the Covenant that was brought here by our ancestors and needs immediate attention to correct the alignment.

The conflict with Britain for the last hundred years is the crown of England and the British Government refuse to recognise, respect and honour the legitimacy of the 1918 32 county all Ireland Democratic Election called by the British Government on the 14th of December 1918. King George V of England and his British Government declared the Sovereign Dáil éireann government to be an illegal assembly and sent his Cairo gang to Dublin to execute and annihilate the Sovereign Dáil éireann judiciary and civil service that were elected by the will and wishes of all the people - citizens of éire all 32 counties and all members of the IRB and on Bloody Sunday the crown forces opened fire on the Sovereign People - citizen at Croke Park, Dublin and killed 14 innocent people "Vaughan Hotel Paper" (source Sam Maguire Intelligence Report).

All my land is 100% de-stocked and my constitutional right to farm and forest my land and earn my livelihood from my farm is breached. That is the judgement of the Supreme Court and nothing is done to rectify my situation at Oorid Connemara, County Galway. Minister Mr. Bobby Molloy TD granted me forestry for my land at Oorid Connemara, County Galway.

High court case number 2002/6783 P high court June 2006 no judge turned up to hear my case and never told me that my case was sent to the European Union.
