King George V of England declared that Dáil Éireann was an illegal assembly, and imposed in 1922, under the threat of "Immediate and Terrible War", a British apartheid system for the 26 and 6 Counties of Ireland and a Provisional Government for the 26 and 6 Counties of Ireland

The Symbols of the State, the Sovereign Republic of Éire are owned and the property of the Irish Republican Brotherhood, who keep them in trust for the Sovereign Citizens of the Sovereign Republic of Éire all 32 Counties
