"The Irish design will consist of the Harp, the word Éire and the year of issue, surrounded by the twelve stars of the E.U. flag"

The Harp is not a Legal Tender.

The Sovereign Seal of Dáil Éireann only, is the Legal Tender

The Harp is a Musical instrument, for example the "Brian Boru" Harp has 29 strings. The Harp is the Reverse side of the Sovereign Seal of Dáil Éireann and is also used by Guinness as their Trade Mark.

The Sovereign Seal of Dáil Éireann has Twelve (12) strings and is a Christian Symbol and Ethos

The Sovereign Seal and the Harp have been the symbols of the Irish People for thousands of years. Especially

the \bar{O} ' and the \bar{M} '

The Sovereign Seal on our Passport, (European Community), has nine (9) strings. We enter a Foreign Country as Sovereign Citizens

The Sovereign Seal on the Euro Coin has Fourteen (14) strings ?

The Sovereignty comes from the 1916 Proclamation and was Implemented by my Granduncle Tom McGuire on the 21st of January 1919 in "Vaughans Hotel" 29 Parnell Square Dublin and the Sovereignty was Vested on the same day the 21st of January 1919 and my Granduncle Placed the Sovereign Seal of Dáil Eireann in the Mansion House Dublin for the first Dáil Eireann on behalf of the Irish Republican Brotherhood

I am the Heir to "Vaughans Hotel" and the Present Sovereign Seal Holder. My family the McGuires have held the Sovereign Seals of Dáil Eireann for (83) Eightythree years on behalf of the Irish Republican Brotherhood

IV

The Sovereign seal of Dáil Éireann are based on the design of the old Irish Harp, The Brian Boru Harp and the sequence of events. The Fenian Brotherhood standard. The Sovereign seal on a green background with a gold Braid, "The Green and Gold".

The Irish Republican Brotherhood who are the successors of the Fenian Brotherhood, Their standard is the Sovereign seal on St Patrick's Blue background with a Gold Braid and after the 21st of January 1919. The Irish Republican Standard. The Sovereign seal of Dáil Éireann on St Patrick's Blue background with the Four Province Emblem of Ireland and a Thirty two Gold Binding Edge.

The Sovereign seal of Dáil Éireann is over the Irish Courts and the Gaelic Athletic Association (G.A.A.) is entitled to have the Sovereign seal of Dáil Éireann on their Emblem.

Tom ^VMcGuire did not place
a Harb in the Mansion ^{House} Dublin for the
First Dáil Eireann. Tom McGuire placed
the Sovereign Seal of Dáil Eireann
which has (12) Twelve strings, in
the Mansion House for the First Dáil Eireann

The Thirtytwo (32) counties election
of 1918. established the sovereignty
of Dáil Eireann and the sovereignty
of the Thirtytwo (32) Counties.

I would like to know how the
European Central Bank is going to
Compensate the Irish Republican
Brotherhood for the Removal of their
Sovereign Seal of Dáil Eireann
from the Irish Legal Tender. The Irish

Does the European Central Bank
still acknowledge the sovereignty of
