The purpose of the hearing is to seek a Declaratory Order from the Sovereign Dáil Éireann Courts on Circuit for the following:

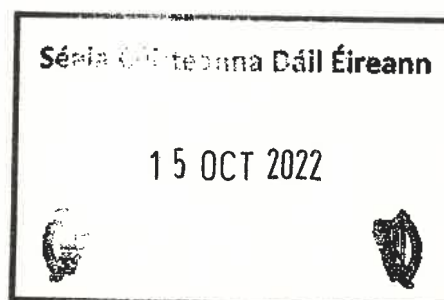
1. The Papal Bull Laudabiliter of 1155 is unlawful and unenforceable against the Sovereign Territory of Éire and the People of Ireland.

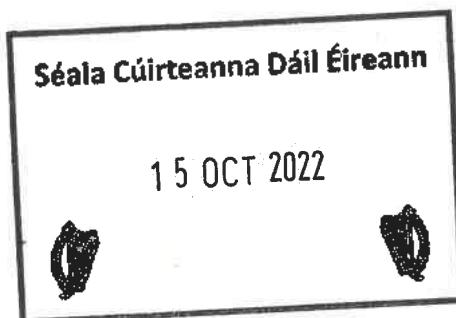

Dear Queen Elizabeth,

I note that we have not received any response from you to our letter dated 22nd March 2022 within the stated timeframe. We take it in the circumstances that you do not contest our stated position that the Papal Bull Laudabiliter of 1155 is void *ab initio*. It follows that any subsequent claims by the Crown to have authority to deal with the sovereign territory of Éire *inter alia* The Crown of Ireland Act 1542 can hold no principle or rule of law or equity.

The Sovereignty of the Nation of Éire is inalienable and the land and the Sovereign Territory of Éire belongs to the People of Ireland and to them alone.

The Irish Republican Brotherhood has publicly restated the claim for the People of Ireland's rights to the Sovereign Territory and assets every year for the last 106 years. These rights are not contested and the ongoing claim remains extant.

Dear Pope Francis,

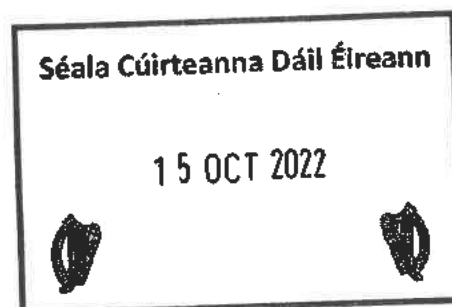

No matter how well One is prepared for such an occasion, it cannot be claimed to be an easy transition.

As Custodians of the 32 County Sovereign Government of the Sovereign Republic of Éire, it is incumbent on the Irish Republican Brotherhood (IRB) to follow the program of the Brotherhood to the full letter of the law, and it is with this vein of resolve that we write to you, having been made aware of certain matters through your recent Proclamation, during this transitional period for your Country, to bring to your attention the following matters of fact, in order to assist you with your purpose.

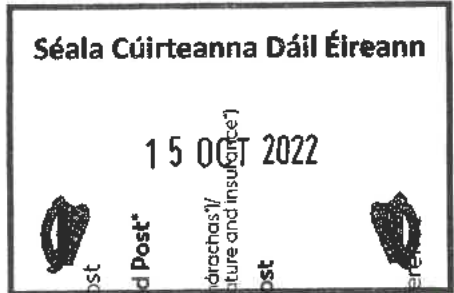

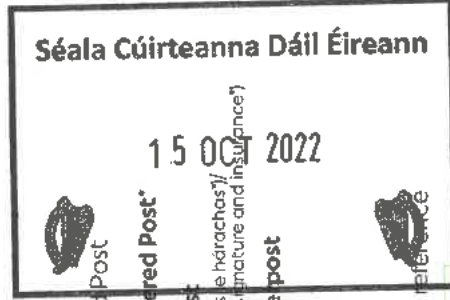
