WITNESS STATEMENT OF WILLIAM JAMES MCGUIRE

I, :William-James: McGuire, Sovereign Claimant in Éire, of Lee House, Cappagh, in the County of Limerick, aged eighteen years and upwards MAKE OATH AND SAY as follows:

1. I was born in 1943 and I was anointed at age 7 at the direction of Pope Pius XII through his Papal Nuncio in St Patricks Church in Limerick Éire in fidelity with the Peace Reconciliation and Prosperity Programme for all Nations and the cause of National Sovereignty in recognition of my father's position as President of the Irish Republican Brotherhood and the President of the Sovereign Republic of Éire.
2. The traditions and customs and duties and responsibilities of the Irish Republican Brotherhood became engrained in me from a very young age and on the passing of my late father in 1964, and by the will and wishes of the Members of the IRB, at the age of 21 years, I was confirmed President of the Irish Republican Brotherhood and by extension the President of the Sovereign Republic of Éire as enshrined in the Constitution of the Organisation.
3. A very important duty of the President is to reissue the Sovereign Licences for Dáil Éireann and the Dáil Éireann Courts and to restate the Claim over the Sovereign Territory and Seas and all the Natural Resources of Éire for the People of Ireland and I have done this during the tenure of my Presidency each and every year on January 21st and I attach to this Witness Statement a copy of the Licence and Claim of January 21st 2022 upon which I have affixed the Sovereign Seal of Éire.
