IN the name of God and of the Dead Generations, I, John Dectan Flanagan, IRB Chairman, being duly authorised by Resolution of the IRB Board on 14th January 2023, hereby claim, as Envoy of the IRB President, William James McGuire, Sovereign President of the Sovereign Republic of Éire, ALL of the Sovereign Territory of the Sovereign Republic of Éire, comprising 220 million acres, or 880,000 square kilometres, or thereabouts, as outlined in purple on the map herein, all Land Air and Water, and all of the assets and resources of the Sovereign Territory of Éire, Therein and Thereof, for the People of Ireland.

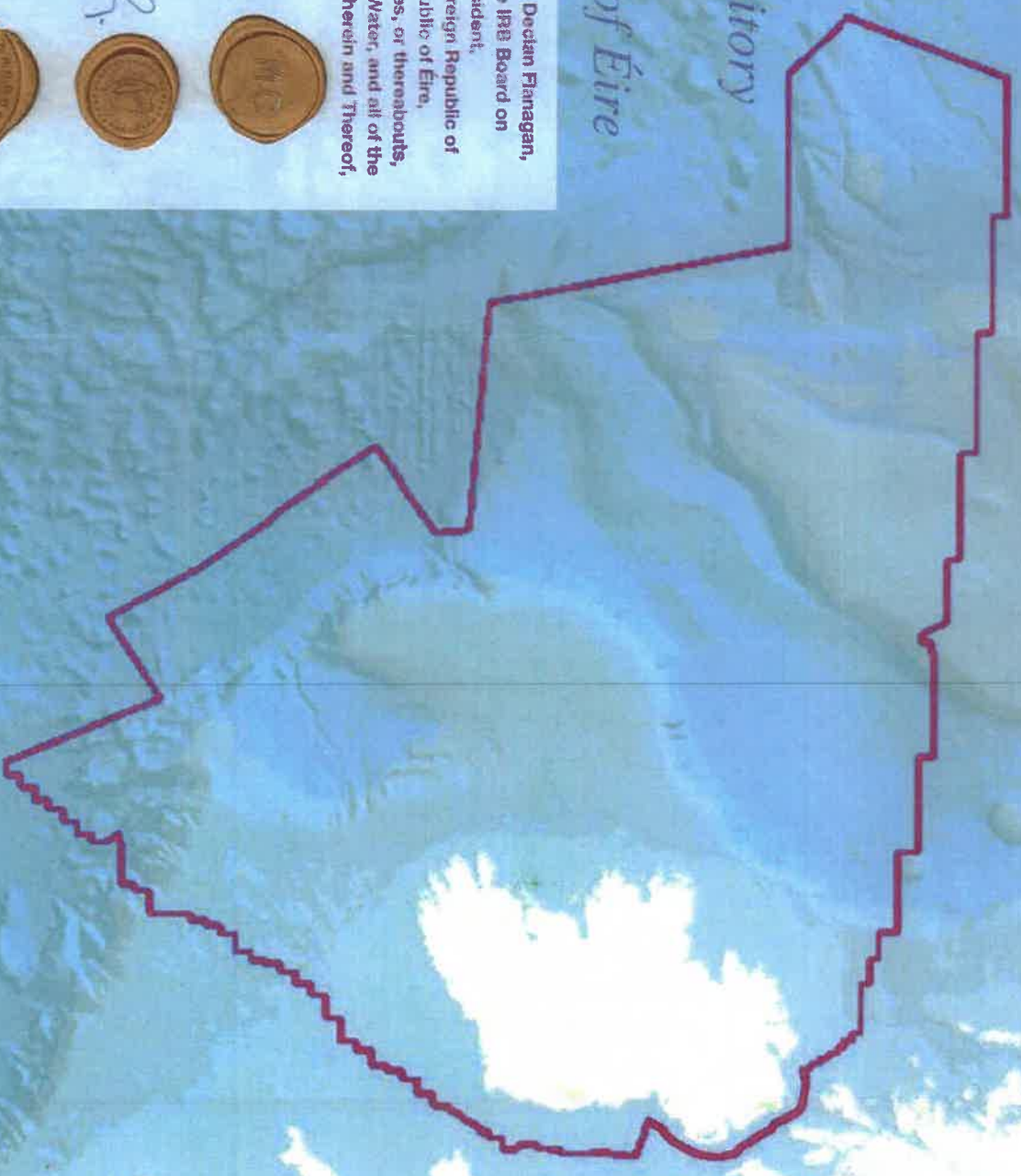
