Policy for Housing

Principle 1: The Republic of Ireland fully recognises the importance of the Family Unit in the Sovereign Republic of Éire and the fundamental right of access to a home for all Men, Women and Children of the Nation. Dáil Éireann will undertake to protect the Family Home as a Foundation Stone of our Nation.

Principle 2: Dáil Éireann will prioritise the Indigenous People of the Sovereign Republic of Éire for housing in the Housing Policy. The State recognizes that stable housing is a crucial underpinning to address other issues that homeless individuals face. The eradication of homelessness in the Sovereign Republic of Éire is a moral obligation.

Principle 3: Dáil Éireann will implement a Homeless Prevention Task Team and Policy to address the root cause of homelessness in Éire. This can include financial assistance, rental subsidies, mediation services for at risk households, and support for individuals transitioning out of institutional settings.

Principle 4: Dáil Éireann will consider Public/Private/Partnership (PPP) in collaboration with Private Developers, Non-Profit Organization and--Community-Groups to improve the supply of affordable housing and to support innovative housing solutions. Rents for dwellings are to be kept reasonable and all equitable input will be taken into consideration for those renters who wish to purchase.

Principle 5: Dáil Éireann must implement mechanisms to ensure that all housing units are of suitable quality and safety standards and where regular inspections and a Maintenance Program can be put in place to safeguard the wellbeing of all residents.

Principle 6: Dáil Éireann will have a Duty of Care to consider the promotion of equitable distribution of housing options and prevent the concentration of poverty in urban areas, encouraging mixed use developments and integrating housing with transportation, small industries, farming and areas suitable for vegetable and fruit growth, with plentiful community facilities that promote learning and arts and culture, on all lands made available for such purposes.

Principle 7: Dáil Éireann will recognise and support relevant initiatives so that the Community can prioritize education to empower Citizens with life skills, job training and resources, to enhance economic opportunities and enhance the overall wellbeing of all Citizens in line with Article 2 & 3 of the Policy for Children.

Principle 8: Dáil Éireann will put such directives and measures in place to ensure that developments will incorporate green spaces, parks and recreational areas, to promote a healthy and sustainable environment for Community Residents.

Principle 9: Public Participation in all decision-making processes on matters concerning Communities is a pre-requisite for encouraging Citizens input, feedback and involvement in community development initiatives.

Principle 10: Communities will have access to Local Healthcare Services and Mental Health Support. Recreational activities will be made readily available to promote physical and emotional wellbeing. The community will foster empathy and compassion, encouraging residents to support each other and extend a helping hand to those in need. Where possible the elderly shall remain within the community to enhance their wellbeing and afford them opportunity to live with dignity in their later years.

Principle 11: The task for the Department of Housing will be on creating a supportive and nurturing environment, where every resident feels valued, respected and included. The Community would be encouraged and incentivised to strive for improvement addressing emerging challenges and adopting ideas to ensure the wellbeing and happiness of its members and the wider community in Éire.

Principle 12: The physical, mental and spiritual needs of the People of Ireland are of paramount importance ahead of any assistance called on for any visitors to our shores. The Land, Seas and Air of the Sovereign Territory of Éire belong to the People of Ireland. There is no provision under our 1916 Proclamation or our 1919 Constitution or the IRB Programme of the Brotherhood where any Foreign Government or Body may own any portion of the Sovereign Territory of Éire.

Principle 13: The Republic recognises the dwelling of the People of Ireland as private and inviolable and shall not be entered without invitation and will be exempt from seizure or sale for any debt through Legal Process.

Principle 14: The Sovereign Republic of Éire purposes initiatives for Native Irish Men and Women to return to their Homeland with incentives through a Resettlement and Relocation Programme in an effort to encourage the return of the Éire Diaspora.
