Meeting continues from Teacher Club/Club na Muinteoirí started at 14:05

Proclamation read by Barra-Séamus dR.

Military Council sitting.

1. Melissa K's response.

An email was sent to Melissa K by the Vice-Chair, Howard-Michael H. seeking clarification on notes left with the President of the I.R.B. William-James (Billy) McGuire with regards to the organisational structure or running of the I.R.B. (notes are unclear). A further email was sent letting Melissa K know that the contents of her response email would be brought to the Military Council for review but should she not hear back on the matter it is not to be taken as agreement with her position with regards to the founding of Óglaigh na hÉireann, the I.R.A. and the IRB Military Council, etc.

Having reviewed the email response it is becoming clear that the agenda of a certain group of people is to confuse those outside of the organisation as to the rightful successor of the President of the I.R.B. However, Billy McGuire has repeatedly told them that he has handed over the responsibility of guardianship of the sovereignty of Éire to the Chair, John-Declan F. This has created a new title for John-Declan F as Commander & Chief Protector of Sovereignty of the Nation-State. This is the highest position for Defence. It will also have recognition of Seal. While the Title is new it is just the merging of two existing posts. There are now three (3) appropriations for the MC seal.

1. Mark of the Chairman which the Chairman's initials will indicate.
2. Military Council which can be initiated by another Member(TBC) of the Military Council
3. Chief Protector of the Sovereign State which will be initiated by the Chair's name in Irish. Currently "SOF" for Seán Ó'Flannagáin

As a point of clarification, since its establishment, Óglaigh na hÉireann has had its name

associated with the formation of a corporation by the same name and had its name referred to the establishment of the Irish Republican Army. (I.R.A.)

The Chair shares that when International Observers were present at the Supreme Council Meeting on the evening of 10th November at G.H.Q. there was recognition that each Council Seat comes with a Seal of the Protectorate for the Sovereign Nation State of Éire .

Proposal; that the 7 members of the Military Council may also hold the role of Sheriff with Seal. The Seal is described as having the Angel from the Óglaigh na hÉireann Title 4 Flag for Communication in front of the Star of David and encompassed in a ring of steel. The proposal carried unanimously.

The 5 remaining seats to be Deputy with Seal. The 7 Sheriff Seals & the 5 Deputy Seals together with the Presidential Sovereign Seal being the 13 Seals of the Protectorate.

2. John-Declan in court.

John-Declan was at the hearing of his case in the District Court in Ennis on Wednesday 15th November 2023 unaccompanied. In his growing awareness of court-speak, he took note of the interaction between himself and the judge.

Having previously furnished his paperwork to the Court Clerk he took note that when his case was called for hearing it omitted the name of the prosecuting Garda and was simply called as "The DPP v FLANAGAN". In response to the case being called by the Judge and the Court Clerk, he presented himself as the Principal Creditor for that Corporation. When the Court Clerk was asked by John-Declan if he had received the paperwork, the Court Clerk appeared to wish to move on quickly by a vigorous nodding of the head. In exchanges with John-Declan, the judge inferred that there was no absolute necessity for him to appear in person and if he had not what would have happened is that a Charge for €150 would be imposed. Further exchanges imply the lack of recognition of law at any level in the District Court with the Judge confirming his obligations to deal with Charges. By extension, no Sovereign should be unduly concerned about a warrant being issued by recognisance once they have correct paperwork before the Court.

John informed the judge that although his presence was not required, he was happy to participate in the process so that everything could be uncovered and we could get to the whole truth.

3. Liaising with Billy

To avoid confusion with regards to succession on the passing of the last life-long President of the Irish Republican Brotherhood (I.R.B.), William-James (Billy) McGuire, John-Brian C. who has been doing Liaising with Billy podcasts has been asked that Billy clarify this in his own words. Billy has repeatedly stated that his role within the Organisation was to carry and protect the sovereignty of the Nation with IRB/ Óglaigh na hÉireann since his anointment at age 7. Billy has now passed this responsibility and authority over to the current Chair John D. Flanagan in union with the IRB Supreme Council.

As President of the IRB and the Sovereign Nation State of Éire Billy continues to hold Seal Position. It can be explained like this, when Billy affixes the Seal on a document gives blessing, when the Chair affixes the Seal on a document it gives protection.

Action items; John-Brian to do an interview and *all* documentation is to be uploaded to the Supreme Council website e.g. syntax salvage, positioning and disqualification documents, policies and minutes from all meetings to be placed in the public domain.

4. Sovereign Bank

The opposition is in full 'de Valera mode' looking to misinform and cause chaos. They know that they do not have authority or sovereignty, unlike the I.R.B. who hold authority to affix the Sovereign Seal. As the Bank moves forward, the golden tri-crown on the blue background Title 4 flag will be that of commerce in the Bank Charter.

5. Pledge

A pledge of support and funding for the I.R.B. has been given. A business plan for the Sovereign Nation State to be created indicating budget spending on resources and offices e.g. for processing E-I-R-E requests and rollout centres for sovereign documentation.

6. Disqualifying the Central Bank of Ireland.

:Jason-Paul : Greaves will be asked to set about disqualifying the current position of the Central Bank of Ireland.

Other work will include setting position, federal etc, for the High Court Dublin, High Court Cork and Ennis District/Circuit Court in alignment with the adornment of the Éire Sovereign Seal Courtroom Shield.
