1. Sovereign Synergy Solutions.

It is clear having reviewed the last recorded session of the talks that the solution to the corporate government that is in place is the Irish Republic and its citizens. The profound importance of the 1916 Proclamation and its ramifications to current Irish society, as it delineates Irish history from the rule of the tri-Crown corporation to God-given sovereignty, becomes understood by the Irish people and there is a greater uptake for the documentation that liberates citizens of the Irish Republic. As this gathers apace, there is a requirement to systemise this uptake to create order out of the chaos after the previous talk in Maldron, Smithfield, Dublin on 28th October 2023.

It also became clear that there is a quid pro quo or host/beneficiary relationship between the Irish Republican Brotherhood and the citizens of the sovereign Republic of Ireland. For the citizens to benefit from the protection of corporate government overreach into their private lives, they are required to swear allegiance to the nation-state.

With the Deeds of Acknowledgment and Confirmation, we recognised the sovereignty of the individual. We captured information such as names, date of birth, locations, skillsets and contact information to show a permanent population. Now, with the reconstitution of Óglaigh na hÉireann, we have an organ that can call for that people's allegiance.



2. SSS Learning Outcomes.

The paperwork processing production became haphazard with requests for different paperwork at different price points. People were unsure as to which documents to avail of, some had cash and some were looking to pay by card and while some were looking to purchase their tab on e-i-r-e.ie others were reluctant to have their details in the public domain.

Going forward there will be a €5 cover charge for each individual. There are five (5) documents that people must complete to move forward with placing their property claim on <u>e-i-r-e.ie</u> and apply for their travel I.D. card. These are:

- 1. Stamped and dated copyright claim Proclamation
- 2. Stamped and dated copyright claim Sovereign Constitution
- 3. Stamped and dated Certificate of citizenship
- 4. Stamped and dated Renunciation of Unam Sanctum
- 5. Stamped and dated Membership of Óglaigh na hÉireann

The cover charge will entitle the attendee to documents 1-3, copies of 1 & 2 will automatically go up on a corresponding tab assigned to them. Niall-Martin to take copies of these for that purpose. When at such time the attendee feels comfortable with proceeding with documents 4 and 5, there will be a €5 charge for each and the application will be processed on receipt of proof of payment. The claimant can request posting of 3-5 at their leisure with confirmation of payment via email.

Initially, there will be an element of trust in providing documents to attendees (especially the Sovereign Citizen Certificate). There are only two requirements;

- 1. That the individual was born in Ireland or;
- 2. That the individual is ordinarily resident in Ireland for 10 or more years.

These requirements are to be conveyed in a slide towards the end of the presentation. As the Sovereign Republic grows and the citizens begin to enjoy a share of the Nation's wealth, there will be further scrutiny of the legitimacy of the applicants.

3. SSS Talk beyond 18th November

Both May and Cork were brought forward as possible locations for the next sovereign synergy solutions presentation. It was agreed after a brief discussion that Cobh in County Cork would be the more immediate location due to a couple of factors. Firstly, Cobh has now been positioned with U.P.U. and claimed and held in Trust on <u>e-i-r-e.ie</u>. Secondly, a nun located there who has been in contact with the organisation may be a candidate to countersign the I.R.B. Unam Sanctum Renunciation. The organisation is looking to bigger venues and a longer notice time in the future in anticipation of greater uptake.



4. Ballyvara 11th November 2023

The speed at which the organisation is moving is highlighted by the upcoming international convention taking place in I.R.B. GHQ the weekend of 11-11-2023. The delegation coming over from Hawai'i has been organised within 6 weeks compared to years for the corporate government to organise a similar event. It is also noted that the delegation is coming over with full acknowledgement of the Hawaiian Sovereign Constitution of 1840 and our own Sovereign Constitution.

For maximum impact, it would be best to have a tripartheid/trilateral convention so Vitali from Norway has also been extended an invite to attend.

There is an expectation that following the convention sovereign embassies will be established in the respective Nations-States of the Kingdom of Hawai'i and the Republic of Ireland.

Another item on the agendum is the issuing of a Sovereign Licence being issued to the Post Master General, Jason-Paul Greaves whose official office location will be the General Post Office (GPO) Dublin. This will be conveyed to the Office of Public Works (OPW).

Eamon-Patrick C and John-Brian C have been charged with chaperone duty for the delegation from Hawai'i.

5. 26 key for 26 locks

Volunteers were sought for this project research. There are 26 locks leading to Belfast which the organisation is looking for 26 corresponding keys/quays. The keys are to be found in the 26 counties, leading to the unlocking of the 6 counties and the 32 counties unlocking a 33rd, sacred location. John-Brian C. Anna-Marie SR and Howard-Michael H have agreed to undertake this search.

6. UCC

A link to allow editing of the Collateral section of the UCC filing to be confirmed so that additional information i.e. a list of the collateral can be added to an existing filing.

7. AOB

Following on from John-Declan's appeal in the High Court 2-11-2023, the judgement will be delivered on Tuesday 7th November 2023. The expectation is that the judge will uphold the Circuit Court Order which will then be appealed to the Supreme Court. It also allows the I.R.B. to bring this judgement to the Sovereign Dáil Éireann Courts and the Federal Courts. It is



noted that when we re-enter the Crown Courts, we have disqualified the Crown of Ireland Act, the Act of Union and Ministries and Secretaries Act, weakening their position and jurisdiction.

Anna-Maire is waiting to hear back from the Minister of Education with regards to homeschooling her son, Liam, and is pausing before responding to TUSLA on this matter.
