### 3. Projects/research

There are ongoing/live projects that require information retrieval for a later date. John-Declan F. has requested those engaged in these projects to have their information to hand for when the time comes to utilise this information.

### 4. Eamon-Patrick C to General Register Office (G.R.O.).

The tri-Crown corporation is the Vatican for souls, the Crown of England for property and Washington for military and global credit. It was previously thought that the Vatican would be the party that dealt with credit and financing but the discovery of paperwork from Eamon-Patrick C. to and from the U.C.C. (Uniform Commercial Code) in Washington D.C. revealed that the global credit system is in keeping there. Filing with the U.C.C. creates an international public record as the individual as the creator of their Trust created through the establishment of their birth certificate as a bond and prevent abuse/maladministration by corporate entities through deception and fraud. There are 4 supporting documents that are required; Common-Law Copyright, Private Agreement, Security Agreement and Hold-Harmless Indemnity Agreement. These documents have been emailed to the Supreme Council members to fill out. All documents to be Notarised to be visible in their system. An Apostille also signs for the legalisation of documents for every nation that has signed up to the Haque Convention.

With regards to the reference number, the suggested format is; Name initials e.g. JDF, followed by the Personal Public Service Number (PPSN) and date of birth. e.g. JDF5816030C-24071971 The purple colour denotes the sovereign citizen beyond corporate influence or interference, creativity, royalty, feminine and spiritual.

Names when claiming Trust credit in documents; both formats of the name to be used, one with the middle initial with the period (full stop) and compound fact version.

The application form for the secured party is very detailed. Receipt of filing is to be sent to the G.R.O. in Roscommon to correct the status on the register. Niall-Martin M to forward the filing URL to the Supreme Council.
