Declaration of Trust

## Affirmation and Expansion of Declaration of Trust of 8th April 2022

### Parties:

- (1) The Irish Republican Brotherhood (IRB) (the "Nominee")
- (2) The People of Ireland (the "Beneficial Owners")

## Background:

#### Whereas:

- A. By the Organisation of the Nominee, the right of the People of Ireland to the ownership of Ireland with the unfettered control of Irish destinies to be sovereign and indefeasible, being declared under the 1916 Proclamation (the "Proclamation) of the Provisional Government of the Irish Republic to the Beneficial Owners; and
- B. The Proclamation being signed on behalf of the Provisional Government by the Supreme Council of the Nominee with the signatories Thomas J Clarke, Seán WacDiarmada, PH Pearse, James Connolly, Thomas WcDonagh, Eamon Ceannt and Joseph Plunkett; and
- C. The 1918 All Ireland General Election being won by IRB Sinn Féin and the 1919 Declaration of Independence and the 1919 Constitution and the 1916 Proclamation being ratified on 21<sup>st</sup> January 1919; and
- D. The right of governance of the Sovereign Republic of Éire being retained by the Supreme Council of the Nominee under relevant Articles of the 1920 IRB Foregoing Constitution (the "Foregoing Constitution"); and
- E. The Supreme Council of the Nominee being restored on 22<sup>nd</sup> February 2022 and the Foregoing Constitution being revised on 17<sup>th</sup> March 2022 and continuing with *inter alia* IRB Executive Orders 22-8-22 & 4291;

The Nominee holds in Trust the Sovereign Territory of Éire as described in the map attached hereto at the First Schedule and all of the Assets therein and thereof such as Buildings, Land, Air Space, Waters, Mines and Minerals, Oil and Gas, *inter alia* those listed as Specific Assets at the Second Schedule for the Beneficial Owners *inter alia* those named in the Third Schedule

#### Terms:

### 1. Declaration of Trust

The Nominee declares that it holds the Assets and all rights in respect of them in Trust for the Beneficial Owners and the Nominee hereby undertakes to the Beneficial Owners in relation to the Assets:

- 1.1 To deal with the Assets at all times in the best interests of the Beneficial Owners
- 1.2 To promptly and fully account for all benefits in respect of the Assets at any time;
- 1.3 To deal with the Assets and all rights and other benefits receivable in respect of the Assets in such manner as it considers to be in the best interests of the Beneficial Owners;
- 1.4 To exercise all rights and other privileges attaching to the Assets in such manner as it considers to be in the best interests of the Beneficial Owners

#### 2. Miscellaneous Provisions

- 2.1 Parties Bound. This Declaration of Trust shall run for the benefit of the Beneficial Owners and their successors
- 2.2 Further Assurance. The Nominee shall do and execute, or arrange for the doing and executing of, each necessary act, document, instrument and/or thing, reasonably within its power to implement this Declaration of Trust
