Dear Attorney General,

It is my  
duty to inform you, that I William J. J.

"Dáil Éireann" and are not held accountable to the Sovereign Irish People. Which is their "Sovereign" duty.

My family saw the corrupt Protestant Landlord Ascendancy system and the corrupt English Parliament system that led to the Famine and the hatred between the Irish and English people and it was my family that purchased "Vaughans Hotel" 29 Parnell Square Dublin as the Secret Head Quarters of the I.R.B (The Irish Republican Brotherhood) Óglach Na Éireann and Michael Collins They were and still are the Supreme Authority and still hold the "Sovereignty and Dáil Éireann" which was never handed over, and now never will be handed over.

"Vaughans Hotel" set up the 32 County election of 1918. The 1st "Dáil Éireann" on the 21st of January 1919. The "War of Independence" on the 21st of January 1919 and "Declared from" "Vaughans Hotel"



and "The Sovereignty" was vested in "Vaughans Hotel" on the same day 21<sup>st</sup> January 1919 after Dail Eireann sat, by my granduncle Tom McGuire on behalf of the "Irish Republican Brotherhood" (I.R.B.), who coordinated the "War of Independence" in "Vaughans Hotel"

The "Sovereignty" is a "32 County" "Sovereignty" and vested in the Irish People. That is how the "Irish People" are "Sovereign" and when the "Irish People" vote the Government, The President, The Army, The Garda Síochána and the Judiciary are "Sovereign" and Subject and accountable to the "Sovereign Irish People". All Irish People North and South are "Sovereign People".

Every year I ask the Government to release Dail Eireann on the 21<sup>st</sup> of January to commemorate the setting up of the 1<sup>st</sup> Dail Eireann the "War of Independence" and the "Sovereign" as a day of Peace and Reconciliation

and in Memory of all the great men and women who achieved our Freedom for us and all the benefits that we enjoy to day. and every year I am ignored by the Government

"Vaughans Hotel" was sold by S.I.P.T.U and gutted after the Michael Collins film was made there.

\* The Peace Initiative of 5<sup>th</sup> July 1993 to 5 July 1994. The Restoration of "Vaughans Hotel" was the Foundation and Cornerstone of the 1994 Cease-fire where the "I.R.A. could speak authoritatively" and "where the cease-fire would hold in all circumstances". Never Honored by the Irish Government nor made known to the "Sovereign Irish People".

The recent revelations of the corruption by the Government in Dail Eireann is tantamount to treason.
