This extraordinary meeting was called to sign off on Education and Irish Language policies before the Chair or the Supreme Council of the I.R.B. left for Bracknell the following morning for the creation of the E.R.B. council.

2. Albion Coat of Arms/Crest

Chairman of the Military Council (MC), John-Declan, shows a working colour version of the Albion Coast of Arms to the Executive and member MMC1, Barra-Séamus for approval and signing for presentation to and approval of the soon-to-be-created E.R.B. council. There was an explanation fo the imagery and was unanimously approved by the Executive and MMC1.

3. Noel McGrath

Noel, his wife Dorota, Oscar and Brendan K were at Ballyvara House to make a superior claim on É-i-r-e of Noel and Dorota's property.

It had become apparent that Brendan K has sought and received 'a favour' with a matter regarding his daughter Melissa K and his grandchildren. The nature of this favour was being used against him. Dorota seems to also be aware of the nature of this favour and was 'on board'. It was remarked that Noel is 'a man on a mission.

In hindsight, Brendan K's role was to stop the rollouts of the Deeds of Acknowledgment either by making them too expensive or free.

Brendan K and Noel McG have been in contact with a sitting member of the Supreme Council, Niall M. It has become a matter of annoyance to them that he cannot be cracked.

4. Anna-Mari Stack Rivas.

Anna-Marie has approached John-Declan regarding a disciplinary hearing. Anna-Marie is a physiotherapist employed by the HSE but was in strong vocal opposition to the mask mandate that was put in place during the pandemic. As such, her comments were recorded and a 45-page witness expert statement was compiled as evidence against her. John-Declan noted that she has been fighting this battle with the HSE alone and consistently demonstrating great inner strength. It was also noted that the expert witness report is a 'God-send' as it contains 'the best' that the 'other side' has to offer and is being used as evidence in an extant proceeding. Her membership of the I.R.B. was approved by the Executive and she will be at the rollout in Cahir, Tipperary on 22-4-23. The Chair will use this opportunity of a full quorum of the Supreme Council to suggest that she be co-opted onto the Supreme Council as Secretary for Health, subject to the approval of the Council having met her in person.

5. National 1916 Commemoration Committee

The National 1916 Commemoration Committee invited John-Declan to attend a meeting with them on 8-5-23 following their A.G.M. on 7-5-23. They want assurance that the I.R.B. are anti-Treaty and does not recognise the Good Friday Agreement.

6. Rollout of Deeds in Cahir, Tipperary 22-4-23
