The first meeting of the Military Council since its reseating on 25-2-23. The posts on the Military Council were proposed and seconded by sitting Supreme Council members.

1916 Proclamation read by Colm G, John-Brian C and James-Patrick N.

Meeting opens 16:12 hrs

1. Brendan K and Melissa K - a chronology of events.

17-3-23 Chair, John F and Carmen J. (at the request of Noel) attend a meeting with Noel Mc. It was asked that this meeting take place face-to-face due to the nature of its content. Noel Mc had been invited to meet previously at the opening of the J. P. Holland centre which he declined. At the meeting, Noel produced a printout of an email which bore TMHL and E.I.R.E communication relating to court assistance that Niall-Martin, Colm G and Eamon-Patrick had been engaged in. Noel tells John F that this is damaging to the I.R.B. although it is not I.R.B.-related material. When Noel is asked if anyone else knows about this matter he replies yes. When asked if the other party is male or female he replies, male but no name was given. Noel also lets John F know that he has something over this male figure.

Brendan K has done an about-turn from calling John F twice a day to belatedly returning John's calls, so it was a relief when Brendan K tendered his resignation. It became apparent that Brendan K had been compromised and the feeling was that if he had been sent, he would not be allowed to leave or be let resign. This was confirmed by a phone call when John F was returning to Clare. He received a phone call from Brendan K saying he may have been hasty in resigning and would like to reconsider his position. Brendan K also confirmed that he was the male figure in contact with Noel Mc

The primary reason for the Military Council to be re-established is to galvanise the organisation with trusted members.



11-11-22 Incidents in the hotel the night of the Court hearing involving Brendan K and John-Brian's mother, Bernadette.

20-11-22 John-Brian and Brendan K are brought together to sort out their differences.

3-12-22 There was an issue that occurred at the Wee House, Omagh between Vice-President Josephine-Dolores C and John-Brian C in which Josephine-Dolores had expressed dissatisfaction with the Chair of the Supreme Council, John-Declan's compilation of the Glossary of Terms.

9-12-22 I.R.B. Christmas party both John-Brian C and Brendan K seemed to be amicable and wearing matching festive jumpers. During these months Brendan K is engaging in exchanges on social media that are not becoming of a Supreme Council member and could be used to defame or compromise the organisation as a whole. Brendan was texted and asked to desist but he doesn't. John-Brian C, as Liaison Officer, makes John F aware of the continued exchanges.

28-12-22 At the meeting in Dublin there is an explanation to Brendan of how his exchanges on social media may be used against us by those in opposition to what we are looking to achieve. Brendan recognises the error of his ways and vows to stay away from or limit his use of social media. When John-Brian is nominated to the Supreme Council to continue his Liaison Officer role, it is seconded by Brendan K.

4-1-23 When collected from Ballinasloe to attend the rollout in Rathfarnham, both Brendan K and Melissa K are looking disturbed. Brendan K tells John F that he does not trust John-Brian C and expresses suspicion of him as Louise Mc has distributed John-Declan's Live Live Claim on social media. Later, Brendan K expresses regret about the John-Brian C issue. Both Brendan K and Melissa K stay with Vice-President, Josephine-Dolores C in Dublin that night.

5-1-23 Brendan K and Melissa K were disturbed again as Josephine-Dolores C has a different version of events than those previously discussed that occurred at the Wee House in Omagh.

Approx. 7/8-1-23 Brendan K contacts John-Declan F to say that there will be a video coming out of John-Brian C doing and dealing drugs. The information comes from "some woman up in the North". John-Declan asks Brendan if he has verified the source. On or around the same date range 7/9-1-23 Brendan K rings John-Brian C to put pressure on him to resign from the Supreme Council because of the imminent video and the damage it would do. John-Declan tells Brendan K that John-Brian C has his and the other members of the Supreme Council's full support. It is at this point that Brendan K stops his usual communication with John-Declan F.



21-1-23 Independence Day. Brendan K still has issues with John-Brian C.

Approx 6/13-3-23 Melissa K is with Josephine-Dolores C in the UK learning about trial by jury. During this time Melissa K has told the Vice-President that the Chair has "boxed them (Melissa K and Brendan K) into a corner" to the point where they will have to step down.

22-3-23 The Vice-President, Josephine-Dolores C tells John-Declan F that she has been in contact with "a good friend and someone whom she trusts" in the North of Ireland. Josephine-Dolores cannot disclose the identity of this person (X) because this person "is in danger". X has told Josephine-Dolores that she can no longer support her as long as John-Brian is in the I.R.B. Brendan K and Melissa K are also put in contact with X through Josephine-Dolores. As X is an unknown person outside of the organisation, this is a betrayal by the Vice-President. These three (3) individuals are now considered compromised.

"DeVelera energy" is present so the Military Council (MC) is mobilised.

2. Military Council Resolutions

The fear of the existing regime is not in individuals but in the creation of a sovereign nationstate. Revolutions are killed by opposing the banking cartel and big pharma. Literally and figuratively.

IRB Resolution 25-3-23A

That the Military Council of the Supreme Council of the IRB be mobilised with purpose to advance perfect and protect inviolably all matters concerning Trade Commerce Treaties & Agreements for the Sovereign Republic of Eire and the People of Ireland. *Carried*

IRB Resolution 25-3-23B

That the Military Council of the Supreme Council of the IRB be directed with the same Principles directing the Supreme Council and the Executive therein as prescribed in the Foregoing Constitution of the Organisation. *Carried*.



IRB Resolution 25-3-23C

That the matter and manner of the resignations of Brendan Kelly and Melissa Kelly from the Supreme Council on 17th March 2023 be dealt with in part under the direction of the IRISH REPUBLICAN BROTHERHOOD CONSTITUTION AS REVISED TO DATE 1920 RESIGNATIONS, DISMISSALS, &c 25. -(a) Any member of the Supreme Council wishing to resign shall give one month's notice to a member of the Executive. *Carried*.

IRB Resolution 25-3-23D

That when the Seal of Approval/Mark of the Chairman M.C be affixed to any Document it be taken to also donate the approval of the Military Council. *Carried. N.B. Silver for MC approval*.

IRB Resolution 25-3-23D

That it be in order for the Military Council to meet independent of a full quorum Supreme Council meeting on matters particular to IRB Resolution 25-3-23A (if passed) as long as all 7 members sit at any such meeting and that the Supreme Council be kept appraised of any decisions taken at any such meeting of the Military Council. *Carried*.

3. Action points update

Barra-Séamus - witness statements are progressing. He has most but not all. This is due to the outstanding witnesses being busy or putting it on the long finger and not through resistance. Barra-Séamus has resolved to put a deadline on the outstanding witness statements. The Chair expressed a desire to speak with these individuals to make them aware that, in addition to their objection of the measures taken during the past 2-3 years, their Constitutional rights have also been breached and their statements should reflect that.

The draft policies for Education and the Irish language are also on track.

Simone has spoken with Barra-Séamus and will attend the hearing as an expert witness. Stella O'Malley is happy to attend using Zoom to speak as an expert witness on the effect of teaching Transgender issues to children.

Kevin T will make enquires for the Sean McDiarmuida centre in Leitrim.

John F will make enquiries about the parish hall in Doolin and check the availability of Ballyvara House for accommodation.

Supreme Council role in absence of a Secretary for Justice and failure to deliver affidavits. John-Declan has asked those present to draw up their top 5 reasons why the Anglo-Irish Treaty is null and void. Also to research if "Great Britain & Ireland" was already a corporation before the agreement i.e. show what corporations were in place in the 1920s.

4. Bank charter.

The bank charter has been drawn up and will be presented to President William-James McGuire to sign and seal subject to the approval of those present. *Carried*.

5. Travel I.D. cards

A scan of the cards bearing the QR code will bring the user to a website tab that has been created expressly and only for sovereign citizens looking to claim a travel I.D. The code will link to their Deed of Acknowledgement and Confirmation, their passport information and birth certificate/ DOB. This will attest to their identity as a sovereign and their claim over their ALL CAPS legal fiction name.

6. The purpose of the I.R.B.

Corporations have contaminated the water of life so that it no longer nourishes or benefits the people. There is a corporate government, a corporate president, a corporate flag (Title 4) and a corporate population (legal fiction). This has been done through the manipulation of maritime law, the law of commerce. We must not recoil or shirk away from Maritime Law as our purpose is to correct the errors we see occurring in this system and set an equitable course that is of benefit to those whom it was intended to serve. The existing system has proven that it is not fit for purpose.

A company called IRBSupremeCouncil Ltd. whose shareholders are the sovereign people with the shares held in trust as a mechanism to prevent corruption, fraud, intimidation, deceit or a totalitarian regime is to be created. It will be the people who own the corporation that will be used to navigate the Maritime trade routes for the benefit of the people i.e. sovereign resources of Land, Air and Water.
