## 1. IRB Education Policy finalised.

A 32-principle education policy finalised by Barra-Séamus dR, Secretary for Education. A printed and sealed copy was presented to the Executive for signing. Approved and signed.

### 2. Bank Charter - English and Gaeilge versions

Two printed and sealed copies of the IRB Bank Charter were presented to the Executive for signing; an English version and one as Gaeilge. Approved and signed.

## 3. Glossary of Terms (5th Edition)

A printed copy of the Glossary of Terms was presented for approval and signing by the Supreme Council. Amendments were made to the previous version of the Glossary, including a footnote of its purpose and remit.

#### 4. Albion coat of arms.

The Chair of the Supreme Council, John-Declan produced the first draft of a design for the Albion Coat of Arms that will progress with project W.I.S.E. Explaining the concept that each of the musical instruments formed the shape of a heart and represent the 4 chambers. Also, the elk/deer is a representative animal for Éire and also on the coat of arms of the McGuire family. The deer is also associated with King Arthur whom it was discovered was of Irish origin. The Supreme Council approved the progression of the concept.

## 5. Josephine-Dolores and Mick Scott - trial by jury

Vice-President, Josephine-Dolores C and Guardian 300 founder, Mick Scott are collaborating on educational material for trial by jury 15-16 April 2023. As they trial and perfect this process, the I.R.B. will be able to use the best of the learning outcomes. Chair of the Supreme Council will be meeting both of the above in Brackley, the original location for the signing of the Magna Carta.

Resolution: John-Declan seeks permission from the Supreme Council to affix the sovereign seal to the first 30 claimants of the Deed of Acknowledgement and Confirmation on behalf of the Executive and that the Vice-President, Josephine-Dolores autograph as a witness. Resolution passed.

## 6. Travel licence/I.D. - Aitheantas Taistil Éire

John-Declan passed around printouts of a design for a credit card-sized travel I.D. to be issued by the I.R.B. to sovereigns who wish to carry one as proof of identity when requested. A discussion ensued about the data safety on the website, language and colour. It was agreed that the information be displayed in Irish (Gaeilge), the Harp be in silver and that if others wished to see who else was a cardholder then that would be of benefit as increased numbers would demonstrate the recognition and approval of the I.R.B.'s work in the cause of sovereignty on an individual and national level.

#### 7. A.O.B.

<u>E-I-R-E.ie</u> progresses with the listing of State-owned land. The aim is to claim 3 properties a week by folio and legal description. The question was posed by James-Patrick with regard to areas of land not registered or without a folio. John-Declan explained that this is covered with the overall territorial claim by the I.R.B. on behalf of the People of Ireland and puts the State on notice of superior title.

Colm G brings an initiative he overheard of Mayo County Council offering to lease land for 12 years to farmers. The feeling was this would be an abdication of the responsibility by May Co Co. Colm to investigate further with regard to the land in question.

#### **Political activists**

It was put to the Supreme Council that we actively engage in finding people willing to deliver the policies of the I.R.B. in the political arena. The message is the I.R.B. will support these individuals or parties who would be oath-bound to carry out this task. Failure to do so or recanting would be seen as an act of theft, trespass and treason and they would be tried in the sovereign Dáil Éireann courts. Corporate governance of the corporation in place, The Government of Ireland and the now defunct Free State have proven to be ineffective. If there is to be a corporation in place then the shareholders of that corporation must be the People of Ireland in order to hold the servants accountable and ensure that they are working in the best interests of the shareholders.

#### Upcoming court sittings.

Teresa Clyne has spoken with the Chair, John-Declan and has informed him that 7 Brehon justices will be present at the Anglo-Irish hearing. Barra-Séamus dR has spoken with Vincent Carroll about his presence as Parish Justice and speak with Josephine-Dolores C.

#### Upcoming policies.

A conversation around suitable candidates to write a health policy brought up many suitable candidates that included Anne McClouskey, Marcus de Bruin, Pat Morrissey and Vincent Carroll. It was suggested that they could convene in GHO, Ballyvara House on the 17th of June to discuss principles of health based on the Programme of the Brotherhood.

The aspiration that the I.R.B. would commence rolling out one policy per month starting with the finalised Education Policy was put to those present.
