1916 Proclamation John-Declan, John-Brian and Howard-Michael.

Meeting opens 14:56 hrs

The Chair, John-Declan presents Josephine-Dolores and Howard-Michael with inscribed rings bearing the sovereign seal of Éire in recognition of work done to progress the cause of the sovereign Republic of Éire.

## 1. Renewal of licence of the Court Registrar

Conditions of renewal read by the Chair, John-Declan and representation of the licence bearing the three seals to the Court Registrar, Eileen-Mary. Unanimous ratification from all present.

## 2. Correspondence to Court Registrar

The Court Registrar received a request by post from the Chair of the I.R.B. for a special sitting with jury for the 24th of April 2023. A response will be returned by post.

#### 3. Court Order Case Record Number 22-11-11 (Gaeilge)

It is proposed that Barra-Séamus, as Circuit Justice, Secretary for Gaeilge and therefore having the capacity to verify the accuracy of the translation and having been present to observe and hear the proceedings, be the third signatory for the Court Order in the Irish language (Gaeilge). Having done this in accordance with the Rules of the Court, the Declaratory Order is now law.



#### 4. E.R.B Council.

There was a unanimous agreement for the selection of members to the Council of the English Republican Brotherhood in Manchester, England. Present were John-Declan who will become Chair of the Council and Josephine-Dolores as a special advisor. The signing for the inception of the E.R.B. will take place on 17th of March 2023.

The 4 principles of nationhood will be progressed. The I.R.B. Executive will be present to record the first 300 sovereigns and thereafter gift them with the flag of the English Republic.

Barra-Séamus feels that his Welsh contact may not have the resolve to accept a role in the creation of the W.R.B. and has suggested that if there are other contacts or leads that they be contacted instead. Josephine-Dolores has suggested that she may have contacts there.

#### 5. E-I-R-E

James-Patrick has been co-opted onto the Supreme Council with special responsibility for the co-ordination of the E-I-R-E. He is ready to proceed and is satisfied with the template provided for recording enrolment.

### 6. E-I-R-E website mapping

The website has started documenting the legitimacy of the claim of the Territory of Éire. The claim derives its authority from the 1916 Proclamation. The claim has been maintained by the McGuire family since 1922 despite Winston Churchill forcing a spilt in the I.R.B. through the unlawful Free State election.

## 7. Consent from the sovereign head for the coronation of Charles.

Sovereignty comes from the ProCreator. The People are sovereign. The role of the I.R.B. is as Protector of the Sovereign Rights of the People. The means by which we do this are the 3Ps - Programme > Policy > Product/Project. This feeds into Parliament/government. The President of the I.R.B. is by fact and by right the head of the sovereign State. For the Coronation of Queen Elizabeth in 1953, Billy McGuire's father was invited to attend. His presence there was taken as a form of consent from Ireland by the Crown. This completed the four (4) required England, Wales, Scotland and Ireland to acknowledge the sovereignty of the Crown and its claim over the dominions. This deception was overcome by the Supreme Council changing the Constitution to delimit the Sovereign President.



#### Overcoming power being vested in a limited number of people

Jason-Paul Greaves is trialling a company in England in which the sovereigns are the shareholders. It was suggested by the Chair that a corporation government of Ireland be set up in which the sovereigns are the shareholders which would prevent the few in administration from being the dominant force in decision-making and in which the goal of the corporation would be to maximise profits for the shareholders. It is the ownership of the Title 4 flag that allows countries/corporations to trade. The shares could be held in trust.

The I.R.B. hold the "the power of the paper". The 1916 Proclamation is an I.R.B. document. We are the authors of the writ and have salvaged the Title 4 Tricolour flag of Éire. There was clarification that Dáil Éireann was rightfully called an *illegal assembly* by the Crown but only in a corporate sense.

A rough depiction of the royal coat of arms was drawn on the whiteboard showing the symbols for the four (4) nations of Wales, Scotland, Ireland and England. Consent from all four (4) is required for Charles III's coronation to recognise his sovereignty. England and Wales will agree, Scotland possibly but Ireland will not. In order to fabricate a recognition of sovereignty from Ireland, Rishi Sunak is attempting to do this through commerce and has created the Windsor Framework. The "green" represents Ireland while the "red" line represents the Crown. However, the I.R.B. have closed off this gap in the border of Ireland's territorial waters with the assistance of Colm Boyle's mapping.

Trial by jury puts the power back in the hands of the people.

#### 8. Car tax

On close inspection, the "car tax" is not a tax but a licence to travel in property (a motor-propelled vehicle) registered to the corporation. This is why they can seize it. The I.R.B., as per the constitution retain the right to levy tax and are working on a display for sovereign car owners. The licence would be aligned with the passport which ensures freedom of travel.

### 9. Sovereign identity cards

The Common Law Courts and Society for Peace have issued credit card-sized identity cards for members to carry. The cards have a QR code or bar code that leads back to relevant information on their websites. John-Declan sought the approval of the Supreme Council to trial such a card for the I.R.B. It was suggested that information that the bar code or QR code would lead back to are 1. The 1916 Proclamation 2. The Declaration of Independence 3. Passport information 4. Personal Deed of Acknowledgement and 5. The Title 4 flag claim.



# 10. Department for the Environment.
