## 1. Óglaigh na hÉireann.

Barra-Séamus reads aloud the Notice to Corporate Government Departments from the Irish Republican Brotherhood. The Notice is a timeline of events that lead to the creation of, leadership of, and entrusted sovereignty of The Irish Volunteers/Óglaigh na hÉireann. It also indicates the divergence between the leadership of the organisation due to John Redmond's desire to control the IV and the subsequent creation of The National Volunteers.

After the split, The IV ratified their Constitution on the 25th of October 1914.

In a Constitution written after the establishment of the Free State of 5th of November 1927, the Army Council adopts the name "Óglaigh-na-hÉireann" .

As the Irish Volunteers/Óglaigh na hÉireann is an Organisation within the I.R.B., it is the remit of the President of the Organisation to make sure that Óglaigh na hÉireann is kept in order. It is pointed out by the present President that all have, should and do respect the factual chronology of the Irish Volunteers/Óglaigh na hÉireann, established to defend the Sovereign Republic of Éire from the Ulster Volunteer Force, an army funded by the Guinness family, Lord Rothschild and Rudyard Kipling and with the backing of the Crown and Crown forces. The symbols of Irish Volunteers/Óglaigh na hÉireann are the 8-string harp of the Volunteers and the 7-string harp of An Garda Síochana. He also points out that the ceremony in the Garden of

Remembrance on 28th May 2023 marked the end of the Civil War as Fianna Fáil and Fine Gael came together to place the wreath.

It is now the responsibility of John-Delcan F. to bring the Irish Volunteers/Óglaigh na hÉireann forward. John-Delcan reads the updated Constitution of Irish Volunteers/Óglaigh na hÉireann with particular attention to 3°3. The Flags of IRISH VOLUNTEERS/Óglaigh na hÉireann are the Naval Flag, the Air Corp Flag and the Irish Republic Flag as set out in the First Schedule hereto. The Irish Republic Flag will stand above 1919mm in the Republican Courts as recognition of Jurisdiction of the Sovereign Dáil Éireann Courts.

All the above-named Flags have been salvaged by the I.R.B.

The updated Constitution is read in stereo by the Chair, John-Delcan agus léigh Barra-Séamus Bunreacht Óglaigh na hÉireann os ard. Constitution is ratified unanimously.

Situation confirmed with Ex-Officio position of Officers - The 4 Members of the Executive will fill the role of Military Judges if/when needed. Eileen Tackney will fill the role of Secretary if/when needed until such time as a Secretary is formally appointed. The Secretary of Defence fills the role of Commander in Chief. Any Member of the Executive can sit as Director of Military Prosecutions as long as he/she is within Jurisdiction of the Military Court Flags.

Vice-Chair Howard-Michael H. is to hold the original Certificates of Appointment and make copies for the records. The originals will be returned to the appointed Volunteers in due course.

The Headquarters of the Irish Volunteers is to be the same as the General Head Quarters and General Head Office of the I.R.B.

## 2. Resolution regarding solidifying claim for People of Ireland.

The Land Registry in Ireland is a record of the legal interest in property in Ireland. Legal interest is the lowest form of interest that one can hold but the other forms have been obscured by legal apparatus in Ireland. The hierarchy of recorded interest is; Legal, Equitable, Beneficial and Lodial. Following the news item that the An Post are vacating the General Post Office (GPO) and that the stewardship of the property would fall to the Office of Public Works (OPW), a Resolution was passed regarding the solidifying of the claim of superior title for the following properties for the People of Ireland on 1) the GPO, Dublin 2) McKee Barracks, Dublin 3) Shannon Airport, Clare 4) Cobh Harbour, Cork 5) James Stephens Barracks, Kilkenny.

The above properties will be enrolled in [E-I-R-E.ie](http://E-I-R-E.ie) with Plan Notice, Fógra an Phleann with Indentures signed and sealed also.

## 3. Addenda to IRB Foregoing Constitution and Glossary of Terms 5th Edition

As William-Jame (Billy) McGuire is the last of life-long Presidents of the Irish Republican Brotherhood, a Resolution regarding the addenda Article 28 A of the Foregoing Constitution - **Succession of President** was read aloud. The addendum reads as follows; "In keeping with the Democratic Spirit of the Organisation, the standing Vice President must firstly be nominated by the Executive for the vacant position of President and the Nomination must then be put before a full quorum of the Supreme Council and passed my unanimous decision of the Board. If no unanimous decision is forthcoming then the position of President of the Organisation will rest **Sede Vacante** until such time as the/a Nomination is passed unanimously by a full quorum of the Supreme Council of the Irish Republican Brotherhood."

Resolution regarding expansion of definition of "Citizen of Ireland" under IRB Glossary of Terms 5th Edition to "A Sovereign Man or Woman in Eire utilising their Entity. One who, under the Constitution is a Member of a Community, owing allegiance and being entitled to religious and civil liberty, equal rights and equal opportunities, with guarantee by Government" passed unanimously.

## 4. Policy for Children.

The Secretary for Children, Eamon-Patrick C. reads the Policy for Children aloud in English. Its adoption by the I.R.B. is passed unanimously.

## 5. A.O.B.

John-Declan F with permission from Eamon-Patrick C reads aloud Eamon's affidavit for his High Court proceedings. Amongst other items, Eamon-Patrick declares his sovereignty, his membership of the I.R.B. and attaches the Fógra an Phleann as it appears on [E-I-R-E.ie](http://E-I-R-E.ie) for the property in question and the accompanying Indenture.
