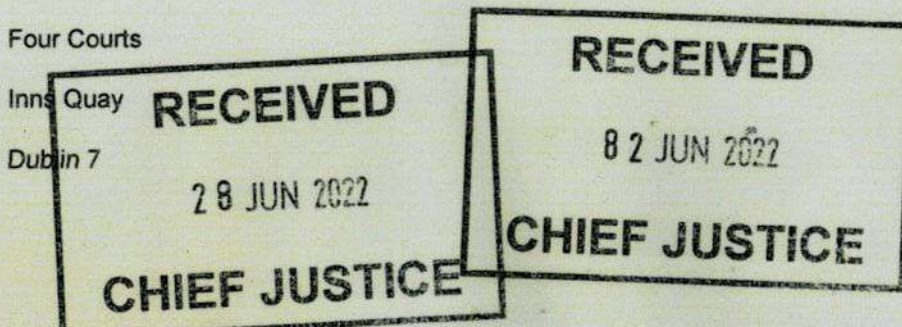

Dear Chief Justice O'Donnell

The Irish Republican Brotherhood would like to bring the following complaint to your attention and believe that "the census of population of Ireland form" is a fraudulent document as it contains propaganda, lies, deception and fraud.

The census form refers to "This is the twenty-sixth census to be held since 1841" but does not say that the 1841 census was a 32 county all Ireland census form or a 26 county Provisional Free State census form imposed by Britain on the 6th of December 1921 (articles of agreement as signed) to partition Ireland as a Free State provisional government for the 26 counties of Ireland and 6 counties of Northern Ireland under Britain to pay for Britain's war debt and war pensions.

The Irish Republican Brotherhood who founded and funded the state, The Sovereign Republic of éire in the 1918 32 county all Ireland democratic election called by Britain (British government) on the 14th of December 1918 and on the 28th of December 1918 (IRB Sinn Féin) won 73 seats, the Unionist party won 25 seats, the Nationalist party won 6 seats, the Independent party won 1 seat out of a total of 105 seats.

This is the mandate that the Sovereign people of éire gave the Irish Republican Brotherhood, the mandate to found the state. The Sovereign Republic of éire all 32 counties all our territory down the Irish Sea with Britain to our border in the Atlantic Ocean with the United States of America (USA) and Canada.

I enclose my original query and reply from the census office (Central Statistics Office).

The census form does say "The Irish census counts all the people and households in the country on census night. This is the twenty-sixth census to be held since 1841" which is correct as there have been 25 census in the period from 1841-2016 inclusive.

The 1841 census was completed on the entire island of Ireland where as census periods since the foundation of the state, Free State provisional government have been for the 26 counties of Ireland.

I have always signed my census form under the Sovereign seal of Dáil éireann, 12 strings AD 1919 under the mandate of the 1918 32 county all Ireland democratic election (Sovereignty is inalienable) the Sovereign constitution (Source Vaughans Hotel papers) "by the will and wishes of the Sovereign people/ citizens of the Sovereign Republic of éire" as the anointed Sovereign of the Sovereign Republic of éire. I claim all our Sovereign territory down the Irish Sea with Britain to our border in the Atlantic Ocean with the

United States of America (USA) and Canada and has always being accepted by the Central Statistics Office as such.

The census form refers to "a fine of up to €44,440 any person who fails or refuses to provide this information or who knowingly provides false information may be subject to a fine of up to €44,440 "

The Sovereign constitution of the Sovereign Republic of éire established in the 1918 32 county all Ireland democratic election by the will and wishes of all the Sovereign people/ citizens of éire clearly states in article 1 of the Sovereign Constitution, source Vaughans Hotel papers.

The Sovereignty of the nation is inalienable. It is therefore not within the competence of any generation of the people to surrender that Sovereignty which each generation holds in trust for the nation. The question of surrender of national independence may not be submitted to an electorate.

The Irish Republican Brotherhood would like to know who gave the Free state Provisional government permission to change the Sovereignty of the nation to a 26 county Free state and a provisional Free State government?

I refer to your correspondence dated 21<sup>st</sup> June, 2022, which was addressed to the Chief Justice.


