Meeting starts at 18:01 hrs for 5 minutes 56 seconds.

Background; Thursday 23rd November 20223, the Commander-in-Chief of Óglaigh na hÉireann issued a notice to the corporate government and its agents about the 'triple lock' removal from the defence forces and signing of the W.H.O. Pandemic Treaty without legal basis. 5 children are stabbed in Parnell Square and a night of violence ensues on the streets of the capital.

1. Alignment.

Chairman of the Supreme Council and Commander-in-Chief of Óglaigh na hÉireann, John D. Flanagan has requested the following of the U.P.U.

- To advance the position for the IRB Sovereign Bank with the alignment of the Three Crowns Title 4 Flag with the IRB Bank Charter and Covenant with In-Ground Assets of IRB Declaration of Trust for the People of Ireland with IRB Sovereign Licence. Disqualification of the current Central Bank position.
- 2. Advance the position for 3 courts of the sovereign Republic of Éire; Four Courts Dublin, the Courthouse on Washington Street Cork and the Courthouse in Ennis Claire with Specific Assets of IRB Declaration of Trust for the People of Ireland with the adornment of the Sovereign Seal of Éire, with Óglaigh na hÉireann with the establishment of the Department of Justice at 22nd January 1919 with IRB transfer of authority with IRB Executive Orders 22-8-88 and 4291, with further alignment of Federal Court Position and Judges, with position for Common Law, Customary Law, Brehon Law, Federal Law and Natural Law as sanctioned at 22nd January 1919.
- 3. Position Office of Éire Post Master General at the General Post Office (G.P.O.) Dublin.
- 4. Position Embassy for Sovereign Kingdom of Hawai'i at General Post Office (G.P.O.) Dublin.
- 5. Position Provisional Government of the Irish Republic at the General Post Office (G.P.O.) Dublin.

6. Position Office for the Attorney General at the General Post Office (G.P.O.) Dublin.

This will be done by 21st January 2024. The Provisional Government of the Sovereign Republic of Éire is *us. We/IRB/Ógalaigh na hÉireann are essentially at the position of January 20th 1919.*
