Proclamation read by Howard M., Eileen M. and John B.

1. A proposal from President, William-James McGuire.

The President of the I.R.B., William-James McGuire has asked that a proposal be put to the Supreme Council as follows; that John-Declan F become a life-long Chairman of the Supreme Council or for as long as he wishes to remain so.

Resolution is passed unanimously subject to John-Declan F. being at all times subject to the Code of Conduct for Members of the Supreme Council and in allegiance with the stated principles of the Foregoing Constitution of the I.R.B.

2. Second Claim of Fact and Declaration of Dominion.

Further research shows a timeline in which Wif/Man is considered "lost at sea" (6 days prior to entering the "birth canal"). Carmen J. reads aloud A Memoir by Kurtis R. Kallenback detailing the Act of God which is "one's unique genesis known biologically as fertilization". The claim made in the papal bull, Unam Sanctum of Pope Boniface VIII remained unchallenged and unchanged until the superior claim of the Proclamation of 1916.

3. Additional to E-I-R-E

Addenda: The suggestion that infrastructure stations be taken into E-I-R-E such as Heuston train station as it was suggested that there are unrecorded journeys at night taking minerals from mines for export. John-Brian C. also mentioned that he and Fionán are also compiling a list of sacred sites in each county and any input would be appreciated.

Carmen J. also pointed out that there are gas deposits and dumps in Cobh Harbour and the coastline fo Ireland that are shown on nautical navigation maps that are not identified on Ordinance Survey maps.

4. Health Policy

The I.R.B. Health Policy has been signed (post meeting) and is ready to be promulgated. It was pointed out that this is only an initial policy and will be amended as required. Eileen-Mary T is working on the Arts and Heritage policy.

5. Anna-Maris SR hearing

A further complaint against Anna-Marie SR has been made by the same individual, Simon Mooney. Anna-Marie expressed her frustration that the barristers provided by the union are not working in her best interest and that the information that wishes to be heard will not be heard. It was pointed out by Eamon-Patrick that as long as she participates in 'their' world, she is bound by their rules (registration and licence) and no positive outcome will come on her behalf. After a short discussion, it was shown that the results from the hearing will not have any major bearing on the continued practice and profession of Anna-Marie as a sovereign in éire who can get a sovereign licence. The advice given was that she proceed with her affidavit which will be stamped with the Sovereign Dáil Éireann court seal be given to the barristers.

Anna-Marie has committed to the first draft being sent to Eamon-Patrick, Colm-Mary and John Declan not later than Friday 25th August 2023. They will work together to create the finished document. It was also suggested that Anna-Marie bring forward a case of defamation against those making the claims against her shifting the onus probandi/burden of proof.

6. Sovereign Synergy Solutions talks.

A talk has been scheduled for the Central Hotel, Donegal Town by Louise Price for 2-9-23. The Liaison Officer, John-brian C. has been speaking with Murlock Murphy and Jerome Murphy, keen proponents of reregistration from the voting register about a talk in Dublin in late September

7. AOB.

Colm-Mary G and Niall-Martin M. are seeking to have a Deed of Acknowledgement and Confirmation for Paul Beirne. Paul is currently incarcerated but it is possible to get the
