Also present is Chief Justice, Josephine-Dolores C. as her agreement is required on an upcoming matter.
There is no objection from the Supreme Council.

The Proclamation is read by Josephine-Dolores C.

1. A draft plenary summons from Michael McD.

John-Declan reads aloud a draft plenary summons from Michael McD that we sent to GHO and a copy to the President, William-James McGuire. In his summons, Michael claims that his inalienable, civil and political rights have been violated and that the Supreme Council have acted ultra vires by removing him from the Council. The Chair reminds those present that part of his role is to protect the organisation. He reads aloud the proposed draft response to the Council who agree unanimously. A copy of the response will be sent by registered post to Michael McD.

2. Corporate veil of the Treaty.

Following on from his research, John-Declan F. as Secretary for Finance, it is discovered that *all* departments within the Government of Ireland corporation have their foundation in and rely on what was created by the first Dáil Éireann in 1919. The Anglo Irish Treaty and subsequent Ministers and Secretaries Act 1924 made the departments a statutory position and placed a corporate veil over the Sovereign government.

Executive Order 4291 lists certain Departments to be restructured and revitalised. Once the pillars are back in place for the Departments we will disqualify the Ministers and Secretaries Act 1924.

As the policies for Health and Education are more advanced, other Acts such as the Health Act 1947 and the Education Act 1997 will be disqualified. With regard to Education, sovereign

children are fully entitled to choose to learn from a different curriculum where their parents see fit.

In the coming week, the corporate bodies/Departments will be informed/notified of the position of the I.R.B. and the Sovereign Department of Justice will be called to investigate the corporate Department of Justice to establish whether or not they have committed theft, trespass or treason against the sovereign People of Ireland.

Colm G raises the question of translating the dead entity term of “a body” from legalise into syntax. John-Declan reasserts that as we, the I.R.B. are the authors of the writ, we can define the term as we understand it.

The Executive Order is signed by the President, the Chief Justice, the Chair and 3 members of the Executive. The Order is read aloud in Irish/Gaeilge by Barra-Séamus dR.

3. G.A.A. matters

Putting Croke Park into E-I-R-E. The Deed of Indenture for Croke Park is signed by Niall-Martin M and John-Declan F.

Darren H. had passed on an invitation for a forum taking place for the amalgamation of the G.A.A., L.G.P.A. and the Camogie Association. With names and addresses given for each of the bodies, it is an opportunity for the I.R.B. to communicate our position as stated in the foregoing constitution and that the President, William-James McGuire hold lodial title of all G.A.A. appointed pitches and lands for the People of Ireland. It is an opportunity to put on record that both Sam Maguire and Liam McCarthy after whom both All-Ireland trophies are named, were members of the I.R.B. The sovereign seal that was on the original issue of All-Ireland medals meant that each member of the G.A.A. was a member of the I.R.B. By removing the Sovereign Seal from the GAA All Ireland Medal the GAA Corporation is depriving the All Ireland Winners of their right to their Seal of Sovereignty.

A return of the G.A.A. to its sovereign status, there would not be a “corporate box” but a Sovereign Station where the President of the I.R.B. would rightfully sit.

The Chair asks for assistance in gather information about the Brotherhood’s involvement with the formation of the G.A.A. along with the ties to Sam Maguire and Liam McCarthy. John-Brian C and Barra-Séamus dR volunteer. Anna-Marie SR will get in touch with her contact in the United States.

4. Sovereign Synergy Solutions talks.

John-Declan indicates his willingness to travel the country in order to deliver the Sovereign Synergy Solutions talks accompanied by A. N. Other member at a frequency of one-per-week. John-Brian C. is to reach out to his contacts as Liaison Officer and arrange venues and dates. The preference is for daytime. Interest has already been expressed in Galway and Cork. With the talks, a streamlined version of the sovereignty rollouts can take place with photo I.D. The Claim of Dominion can be used and the Irish version of the Deed of Acknowledgement of Sovereignty.

5. New members

Members of the Supreme Council have been approached seeking to become members of the Irish Republican Brotherhood. new members include Alan O'Neill, Sharon Quigley and Paul McGuire, Conor and Rósín O'Brien. It is suggested by John-Declan that the more pressing and beneficial membership would be Óglaigh na hÉireann. They are to fill out the form and return to Eileen-Mary T.

6. Travel I.D.

Design change suggested for the reverse of the Travel I.D. The QR code to be the same silver as the background and to include the phrase from the passport "the barer. to pass freely and with our hindrance..." and to include the signature of the Sovereign president, William-James McGuire. The Travel I.D. would tie in with the replacement of the car tax/permit to travel and expand its classifications to include those who wish to covey machinery. The question was asked as to why we are required to have our current licences renewed. This affords a level of protection to the issuer from mis-use of such a licence.

Fees from the Travel I.D./travel licence would go to fund the Sovereign Dáil Éireann Courts which is the protector of those licences. It would be a sovereign licence for your property ("vehicle" is a commercial term as is "driver").

7. Sovereign stations.

Further locations to be placed in Trust for the People of Ireland via E-I-R-E will now include The Four Courts and the Mansion House.

8. Housing Policy.

Colm G and Niall-Martin M have created a Housing Policy for the I.R.B. to deliver. The notion of seeking permission to build on your own land (planning permission) begs the question - who owns the land? It could reasonably be assumed that anyone seeking to build their dwelling would have consideration and respect for the land, their neighbours and their dwelling. Further discussion brings up the suggestion that small businesses and sole traders

should be allowed to construct working capital on their property subject to the number of employees and requirements i.e. not a factory. Renovation of existing buildings should also be excluded from seeking permission. Government intervention should only be required on a corporate-to-corporate scale.

9. Deed & Declaration of Renunciation.

The Cestui Que Vie Trust from the Act of 1666 makes the assumption that the Government the Trustee of the Trust. The Trust is created through the Birthing Certificate and the beneficiary of that Trust is the individual whose name appears on that Certificate. Contained within the Trust is any property that the living person acquires during the course of their lifetime. Due to the above assumption and lack of knowledge of the individual, the Government administers that Trust without the beneficiary being aware. The forerunner to the 1666 Act is the Papal Bull of Boniface VIII, Unam Sanctum which laid claim to all souls and property of the world.

This remained unchallenged until the 1916 Proclamation changed the script. The Claim of the 1916 Proclamation has remained unchallenged allowing the People of Ireland to make a higher claim than that of the Cestui Que Vie Act.

Proposal - that the Deed and Declaration of Renunciation be worded to remove access to abuse of the Trust and remove any other ability to make such a Claim in the future.

10. Sovereignty to America.

There were [several Irishmen in Christopher Columbus' crew](#). One of those is Patrick Maguire. In 1492, Irish-born Maguire was the first crew member of Christopher Columbus' to set foot on North American ground. This brings a better understanding to the President's iteration that 'we' brought sovereignty to America. With this revelation, the Fenian Brotherhood will be advanced in the U.S. It was through Columbus that the corporation was formed.
