Meeting opens 16:22hrs after a Deed of Acknowledgement claim.

1. Sample of I.R.B. travel I.D.

John-Declan shows the Council a test, credit card-sized identity card that can be used for travel domestically and internationally. It is being brought as a test on a trip abroad to see if it is accepted. The QR code on the reverse takes the user to the <u>E-I-R-E.ie</u> website, submenu S.C. (Saor Claine) and to F1 (in this case for "Flanagan" the clan name of John-Declan). There, the user will find all the supporting documentation declaring the sovereignty of the individual and their removal from the Crown corporation.

John-Declan is also testing the additional information in his passport, riveted to the page facing the corporate persona information page. The additional information contains the family crest, the salvaged flags of the defence forces and the vessel doc number.

2. Live-Life Claim.

Barra-Séamus dR is moving forward with his Live Life Claim and Eileen-Mary T and Kevin T have volunteered to witness his claim.

3. Bring forward Health and Education policies under Title 4 flags

John-Declan was speaking with Jason-Paul Greaves about bringing the matters of Health and Education under a Title 4 flag in order to exercise more authority in these areas. The Title 4 flag in education will prevent the current indoctrination in school curricula. The Secretary for Education, Barra-Séamus dR expressed his concern and urgency for a reform to the current SPHE curriculum pervading the current education system at both primary and secondary levels.

4. Health Care

Naas Private Members card and Society of Peace ICC card have been used successfully in the health system as evidenced by Joe Curry. It is the aim of the I.R.B. to position certain hospitals under the Title 4 flags in order for the sovereigns to receive effective, affordable and uncomplicated healthcare.

5. 5 properties claimed on E-I-R-E.ie

Superior titles to Shannon Airport, James Stephens Barracks, Cobh Harbour, McKee Barracks and the General Post Office have all been claimed and are held in Trust for the People of Ireland by the I.R.B. The Office of Public Works (O.P.W.) mentioned in their magazine that the G.P.O. will remain 'public' after being vacated by An Post. The importance of Cobh Harbour being claimed is that it was the post 'captured' in the Anglo-Irish Treaty. Future venues include the Mansion House and the Four Courts.

Side note: During this conversation, some clarification was given to the position and role of the Universal Postal Union (U.P.U.). In the world of commerce, the U.P.U. is the highest venue for credit and contracts and holds the Golden Rules of Commerce. As such, we look to the U.P.U. to disqualify the claims of commerce placed by the corporations on venues and institutions as mentioned above i.e. healthcare and education. In doing so it allows the I.R.B. to make a superior claim for the resources placed in trust for the People of Ireland.

6. Licence for the I.R.B. bank.

A licence is being issued for a sovereign bank being established by the I.R.B. for the People of Ireland.

7. 12th of July - Disqualification.

Wednesday the 12th of July 2023 marks the end of the 45-day notice period in relation to the Claim for the Disqualification of the Government of Ireland Act 1920 and the Claim for the Disqualification of the Anglo Irish Treaty 1921. Further 3 consecutive days' notice is to be given in writing and email to the acting Attorneys General of Northern Ireland and Ireland to follow U.P.U. procedure. John-Declan F asks Howard-Michael H if he could follow up with these three days' correspondence as he is indisposed at that time. Howard-Michael H accepts.

8. AOB - open table.

Eamonn-Patrick C is in the High Courts again on Monday 10th July 2023 to have his case against the CSSO/State with regards to his repossession order and request to investigate 3 counts of fraud that were committed by the parties involved. Are the Attorney General and the Chief State Solicitor here to protect the Constitutional rights and the State's assets?

Michael McCarthy and Teressa McCormac have 2-3 people looking to place their properties in E-I-R-E.

Kevin T asks if we should have a seminar on Trust Law? Teresa Clyne could deliver the course along with John-Declan. The suggestion is that this would take place in October. John-Declan also asks Kevin T to covey to Teresa Clyne that the I.R.B. are happy to supplement the training of Brehon with €1,000 from the E-I-R-E revenue.

Resolution: That Books and Records including minutes of meetings of the Supreme Council of the I.R.B. will be maintained and may be retained in part by members of the Supreme Council. Resolution carried with no objections.

Barra-Séamus dR - special teachers have been sourced and commissioned for immigrants. Could teachers be commissioned to teach children of the Sovereigns under the Title 4 flag? Can there be a choice to teach a different curriculum?

Anna-Marie SR raises concern at a parent-teacher meeting about what is being taught in primary school regarding adult language and themes. She was reported to and received communication from Tusla with regard to the wellbeing of her child. A decision has been made by her and her husband to homeschool their son. John-Declan F relates his recent experience with Tusla to which he informed them, "Your government is not my government and you have no business calling me." i.e. they have no jurisdiction over the Sovereign People of Ireland, he was left alone. Barra-Séamus - "Stand in your power". Speak with conviction when dealing with them.

Anna-Marie was encouraged to get her affidavit started for the fitness to practice enquiry taking place. It is suggested that she bring her affidavit in to the U.P.U and the Sovereign Dáil Éireann Courts.

James-Patrick N - the Education Minister in Northern Ireland is pushing the trans agenda and asks if there is some communication that I.R.B. could enter to the education department there to intervene. Barra-Séamus dR informs the meeting that the INTO is a 32-county body and can send in a cease and desist notice to the Northern Ireland branch.

Any I.R.B. member is free to speak in a personal capacity on matters so far that it is clear that it is understood that they are not the views of the I.R.B.
