Declaration of Trust

The Declaration of Trust dated 8<sup>th</sup> April 2022 updated and reaffirmed this 16<sup>th</sup> August 2024

Parties:

- (1) The Irish Republican Brotherhood (IRB) & Óglaigh na hÉireann (together the "Nominee"); and
- (2) The People of Ireland (the "Beneficial Owners").

Background:

Whereas:

- A. By the Organisation and Openness of the Nominee, the right of the People of Ireland to the ownership of Ireland and to the unfettered control of Irish destinies to be Sovereign and Indefeasible, being declared at 12:04pm Irish Rising Time (IRT) under the 1916 Proclamation of the Provisional Government of the Irish Republic to the Beneficial Owners (the "Proclamation"); and
- B. the Proclamation being signed on behalf of the Provisional Government by the Supreme Council of the Nominee with the signatories Thomas J Clarke, Sean MacDiarmada, P.H. Pearse, James Connolly, Thomas MacDonagh, Eamonn Ceannt & Joseph Plunkett; and
- C. the 1918 All Ireland General Election being won by IRB Sinn Féin and the Proclamation and Declaration of Independence and Sovereign Constitution and Sovereign Dáil Éireann by the Will and Wish of the People of Ireland being ratified on 21<sup>ST</sup> January 1919; and
- D. the right of governance of the Sovereign Republic of Ireland being retained by the IRB Supreme Council of the Nominee under the IRB 1920 Constitution as revised from time to time (the "Foregoing Constitution"); and
- E. the Supreme Council of the Nominee being restored on 22 February 2022 and the Foregoing Constitution being revised subsequently on 17 March 2022, With Óglaigh na hÉireann reconstituted on 17<sup>th</sup> June 2023, and same galvanised with Decree Absolute of 14<sup>th</sup> December 2023, and
- F. IRB Executive Orders 22-8-22, 4291 & 24-06-07, and IRB Presidential Order 8-8-24, and the Seals of Office for the Sovereign Dail Departments as sanctioned by the Sovereign President on 5<sup>th</sup> July 2024, in furtherance of position of the Sovereign Nation State;



The Nominee holds the Sovereign Republic of Ireland, and the Sovereign Territory and Nation State of Éire, as shown on the map attached hereto at the **First Schedule**, including all of the Assets such as Public Buildings and Public Spaces, lands, air spaces, waters, mines and minerals and all natural resources, therein and thereof (the "Assets") including but not limited to those listed as Specific Assets at the **Second Schedule** as extended from time to time and attached hereto on behalf of the Beneficial Owners.

## Terms:

### 1. Declaration

The Nominee declares that it holds the Assets and all rights in respect of them in trust for the Beneficial Owners and the Nominee hereby undertakes to the Beneficial Owners in relation to the Assets:

- 1.1 to deal with the Assets at all times in the best interests of the Beneficial Owners;
- 1.2 to promptly and fully account for all benefits in respect of the Assets at any time;
- 1.3 to deal with the Assets and all rights and other benefits receivable in respect of the Assets in such manner as it considers to be in the best interests of the Beneficial Owners;
- 1.4 to exercise all rights and other privileges attaching to the Assets in such manner as it considers to be in the best interests of the Beneficial Owners

### 2. Miscellaneous Provisions

- 2.1 Parties Bound. This Declaration of Trust shall run for the benefit of the Beneficial Owners and their successors.
- 2.2 Further Assurance. The Nominee shall do and execute, or arrange for the doing and executing of, each necessary act, document, instrument and/thing reasonably within its power to implement this Declaration of Trust.

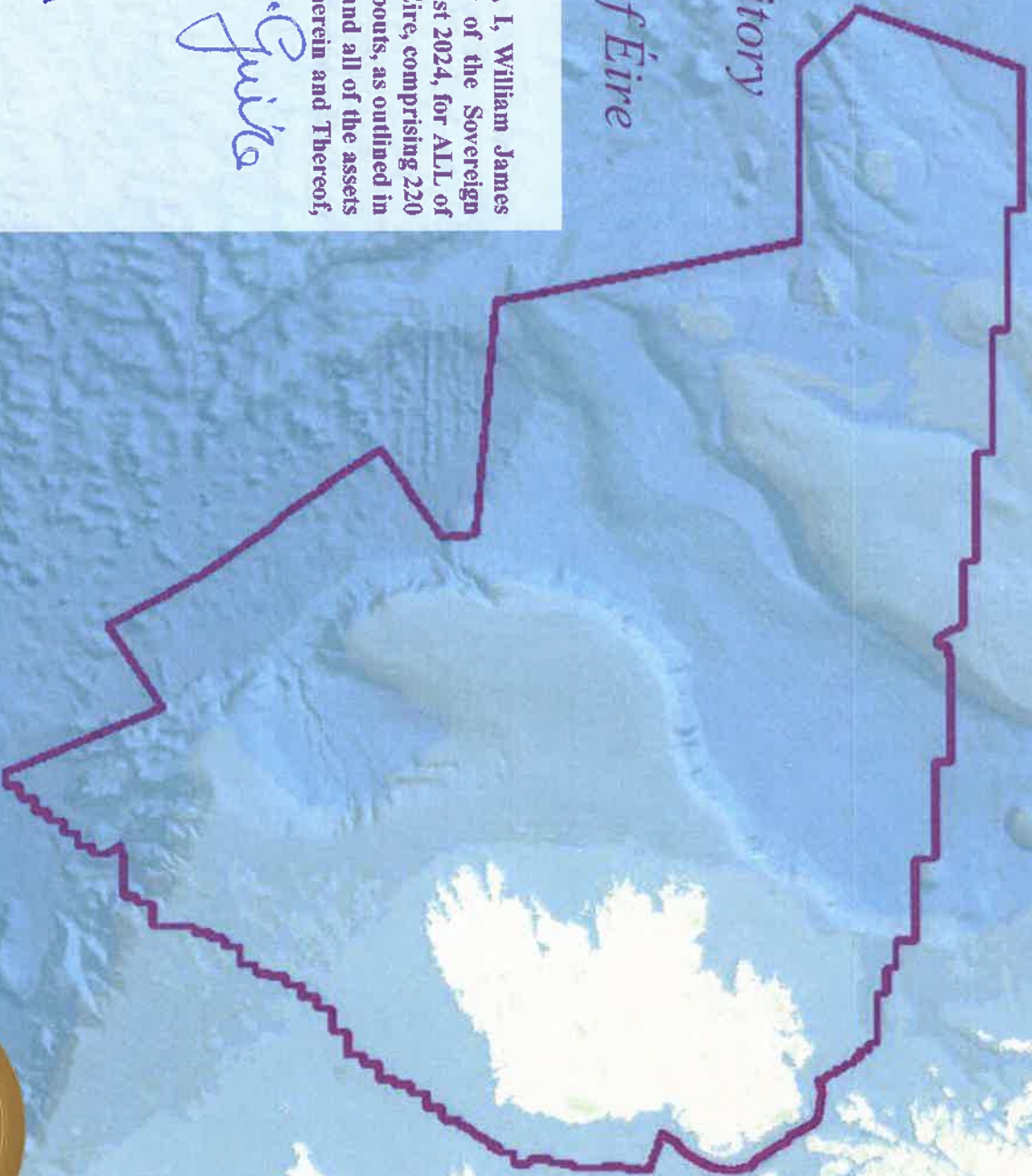
